Distribute K-1's Electronically with SafeSend One


The majority of our returns are being delivered via SafeSend One. For those returns that produce K-1's for the Partners, SafeSend One has a feature to quickly distribute the K-1's to the recipients electronically.

Tips:

- K-1's can only be distributed once the return has been signed.
- The deliverer of the K-1 will receive an email notifiation if the recipient declines to consent to receive the K-1 electronically.
- Mailing paper copies? You can download each K-1 individually or all together to print and mail.
