IRS Accepting Electronic Payments Only Beginning 9/30/2025

The time has come to start making and receiving payments to and from the IRS electronically if you haven't been already.

The IRS accepts electronic payments a few different ways:

- Direct Pay with your bank account (no extra fees)
- Debit or Credit Card (extra fees by processor)
- Your IRS Account (our recommendation)
- For Businesses - EFTPS

All of these methods are safe and secure. Remember to save payment confirmations for your records.

*****Make sure your Tax Accountant has your bank information for any refunds as the IRS will only provide electronic refunds.***

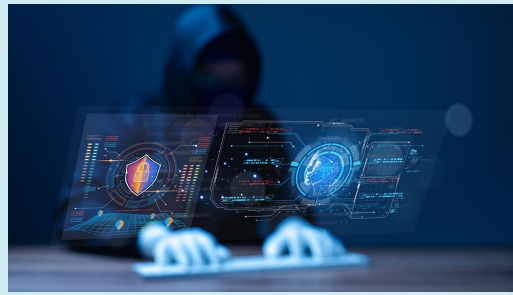
